PUBLIC NOTICE

Jaiprakash Power Ventures Limited (JPVL) has filed a Petition for true up of Generation Tariff of its 2x660MW, Coal based Jaypee Nigrie Super Thermal Power Plant at Nigrie for FY 2021-22 determined by the Commission's Order dated 03.05.2021. The subject Petition has been filed under Section 62 and 86 (1)(a) of the Electricity Act, 2003 read with Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for determination of Generation Tariff) Regulations, 2020{RG-26 (IV) of 2020}.
