PUBLIC NOTICE

Jaiprakash Power Ventures Limited (JPVL) has filed a Petition for true up of Generation Tariff of its 2 x 250MW, Coal based Thermal Power Plant at Bina for FY 2021-22 determined by the Commission vide MYT order dated 30/04/2021. The subject Petition has been filed under Sections 62 and 86 (1)(a) of the Electricity Act, 2003 read with Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for determination of Generation Tariff) Regulations, 2020{RG-26 (IV) of 2020}.
