PUBLIC NOTICE

M/s Jhabua Power Limited (JV of NTPC) has filed a petition for True Up of Generation Tariff of its 1X600 MW, coal based Thermal Power Project (Phase I) at Barela-Gorakhpur, District Seoni, Madhya Pradesh for FY 2021-22 determined by the Commission's vide MYT Order dated 08/05/2021. The subject Petition has been filed under Section 62 and 86 (1)(a) of the Electricity Act, 2003 read with Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for determination of Generation Tariff) Regulations, 2020{RG-26 (IV) of 2020}.

The break-up of the Annual Capacity (Fixed) Charges (AFC) claimed for true-up of the tariff determined by the Commission for FY 2021-22 are as given below:
